### :: Country reports



New country reports on the status of implementation of the EPBD are now available for **Austria, the Czech Republic, Greece, Latvia and Luxembourg**, as well as an update on the implementation status in the **Netherlands**.

### :: Progress in EPBD implementation

Three countries have made further progress towards EPBD implementation:



The Regulations on technical passports for construction works has been implemented in **Bulgaria**. Technical passports have been introduced as documents which contain the technical characteristics of the construction work elements and include the building energy passport (label) as an integral part.



A new online interactive tool has been launched in the **Netherlands** which provides information on energy efficiency measures and advice on potential savings to householders.



The Royal Decree on the Energy Certification of New Buildings in **Spain** establishes processes for the introduction of energy certification for new buildings.

### :: EPLabel Online now live!



A new website has been launched which produces a demonstration version of an energy performance certificate suitable for display. EPLabel Online is an easy-to-use and robust system based on Operational Ratings which is aimed at owners, occupiers and managers of public buildings.

Developed by the IEE SAVE EPLabel project, the website aims to help Member States as they finalise their national legislation, in fulfilment of EPBD Article 7.3. The software works with the data and languages of fifteen European countries/regions. This facility required not just a basic translation, but also a challenging harmonisation of the meanings of terms in the context of different traditions of building energy assessment. The software complies with the new CEN standards.

### :: IEE Programme (2007-2013) and the Call for Proposals 2007



The Intelligent Energy Europe Call for Proposals 2007 has been launched with a focus on either local areas or on subjects considered of particular interest, such as bio-businesses, co-generation or energy services. There is more funding per project available, with up to 75% of the eligible project costs supported.

Projects should be designed to contribute to enabling policies, market transformation, behavioural change, access to capital, and training. Funding for the creation of new local or regional energy agencies will continue to be available to public authorities, but only one applicant will be required.

### :: MEPs launch Energy Efficiency Watch



On 6th March 2007, 5 MEPs launched a new coalition to inform and influence EU and national policymakers on energy efficiency. They have been joined by representatives of several EU- industry associations. At the press launch, the MEPs called for "action, not talk" in view of Member States' hesitations to introduce serious measures to improve energy efficiency.

The [Energy Efficiency Watch](#) will accompany and monitor developments on energy efficiency, offer best-

practice advice to governments (which are required to prepare national energy efficiency action plans by June 2007) and provide an internet site for energy efficiency communication. The budget for the initiative is €400,000, with half coming from an EU project and the rest invested by companies with an interest in the issue.

### :: FIEC position on the European Commission's Action Plan for Energy Efficiency



FIEC holds the view that only very robust and determined measures will significantly reduce greenhouse gas emissions from buildings. However, it feels this will not be achieved unless the present dysfunctions in the market are eliminated, and proposes that regulators must implement measures that will encourage building owners and energy providers to take advantage of every available possibility to correct these market failures.
